In respect of Sections II and III of AVN1C only. All sub-paragraphs except (b) of AVN48B are deleted. Limit in respect of Section II of AVN1C in paragraph 3 is USD 50,000 each occurrence and in the annual aggregate. This Limit being included within the Sum Insured and not in addition to.

AVN60A - Personal Injury Extension.

Limit of Liability shall be USD 50,000 any one offence which is included within the Sum Insured and not in addition to, in the aggregate during the Period of Insurance.

AVN2001A - Date Recognition Limited Coverage Clause. 2488AGM00003 - Asbestos Exclusion Clause.

Not applicable to Section I of AVN1C.

Cancellation AVN38B and AVN52E

Cancellation Clause (applicable to all coverage) 30 days other than in respect of Extended Coverage Endorsement AVN52E and Nuclear Risks Exclusion Clause AVN38B where cancellation provisions of each clause remain paramount.

Contractual Provisions:

Notwithstanding General Exclusion 6 of Section IV (A) of AVN1C and General Condition 2 Section IV (C) of AVN1C, additional Insureds, hold harmless agreements, waivers of subrogation, breach of warranty, loss payees, severability of interests, maintenance and other contractual agreements in force at the commencement of this Insurance are automatically included. Any further such agreements entered into by the Insured in accordance with their operations are automatically included in this Insurance.

Certificate of Airworthiness flights Clause.

Flights undertaken for purposes of renewal of Certificate of Airworthiness and other flights performed under local Aviation Authority permit or waiver.

Check Flights Clause.

Check flights under the supervision of an approved pilot with the necessary licence from the appropriate local authority.

Disappearance amendment.

In Section I, paragraph 1. (a) of AVN1C reference to 'sixty days' is amended to 'ten days'.

Various flights by pilot being approved by local authority

Licence up-rating flights, maintenance flights and Certificate of Airworthiness flights with provision for such flights to be performed by pilots not conforming with the pilot provision but such pilots being approved by the local authority to perform such flights.

Where permitted under the uses stated and notwithstanding anything contained herein to the contrary, in the event of there being an instructor and a student pilot on board the aircraft, the instructor shall be deemed to be the pilot and the student pilot the passenger, therefore being covered under the Passenger Section of the Policy. It is also agreed that if the student pilot is making a solo flight, the student will be deemed to be the pilot and shall be excluded from cover under the Passenger Section of the Aircraft.

Including Total Loss Clause.

In Condition 3 (c) of Section I of AVN1C, the following words are deleted "Except where the Insurers exercise their option to pay for or replace the Aircraft".

Physical Coverage Clause.

The heading of Section I of AVN1C is amended to read "SECTION I PHYSICAL LOSS OF OR DAMAGE TO AIRCRAFT". Under Coverage 1. (a) of Section I and the final paragraph of Exclusion 2 of AVN 1C the word 'accidental' is deleted and replaced with the word 'physical'.

Under Coverage 1. of Section II of AVN 1C wherever the word 'accidental' appears it is deleted and replaced with the word 'physical'.

Under Coverage 1. (a) of Section III of AVN 1C the word 'accidental' is deleted and replaced with the word 'physical'.

Occurrence Clause.

Wherever the word "Accident" appears in AVN1C it shall be deleted and replaced by the word "Occurrence", except for the following:

- 1. In the opening paragraph of AVN1C the words "Accident occurring" are deleted and replaced by the word "Occurrence".
- 2. In Section II, Coverage 1. of AVN1C, the words "accidental bodily injury

(fatal or otherwise) and accidental damage to property caused by the Aircraft or by any person or object falling therefrom." are deleted and replaced by the words "bodily injury (fatal or otherwise) and damage to property caused by the Aircraft or by any person or object falling therefrom arising from an Occurrence."

- 3. In Section III, sub-paragraphs 1. (a) and 1. (b) of AVN1C are deleted and replaced by the following sub-paragraphs:
 - "(a) bodily injury (fatal or otherwise) to passengers whilst entering, on board, or alighting from the Aircraft and
- (b) loss of or damage to baggage and personal articles of passengers arising out of an Occurrence"In Section IV (D) of AVN1C, Definition 1 "ACCIDENT" is deleted and replaced by the following Definition:
- 1. "OCCURRENCE" means an accident or a continued or repeated exposure to conditions occurring during the Period of Insurance, which results in bodily injury and/or property damage which is neither expected nor intended from the standpoint of the Insured. All bodily injury and/or property damage arising out of such exposure to substantially the same general conditions shall be deemed to arise out of one Occurrence.

AVN72 - Contracts (Rights of Third Parties) Act 1999 Exclusion Clause. AVN111 - Sanctions and Embargo Clause.

AVN2000A - Date Recognition Exclusion Clause. Cancellation Clause

General Condition 4 of Section IV of AVN1C and Condition 6 of AVN113 are
deleted and replaced by the following Clause:

"Cancellation Clause:

This Policy may be cancelled by either the Insurers or the Insured giving 30 days notice in writing of such cancellation. If cancelled by the Insurers they will return a pro rata portion of the premium in respect of the unexpired period of the Policy. If cancelled by the Insured a return of premium shall be at the discretion of the Insurers. There will be no return of premium in respect of any Aircraft on which a loss is paid or is payable under this Policy."


